CORRIGENDUM NO. 1

Reference: Request for Proposal (RFP) for Supply, Installation, Testing, and Commissioning (SITC) of Two (2) Ten-Passenger Machine Room-Less (MRL) Elevators

This Corrigendum is issued to amend certain clauses of the Request for Proposal (RFP) document referenced above, issued by Sri Guru Gobind Singh College of Commerce, Pitampura, New Delhi. All prospective bidders are requested to take note of the following modifications, which shall form an integral part of the RFP document.

1. AMENDMENT TO SECTION 1: INTRODUCTION - "APPROVED MAKES OF LIFTS"

The sub-section titled "Approved Makes of LIFTS" under Section 1 (Introduction) of the original RFP document is hereby deleted in its entirety. Procurement will be guided by the revised eligibility criteria outlined below.

2. INSERTION OF NEW CLAUSE: REVISED ELIGIBILITY CRITERIA FOR BIDDERS (LIFT MANUFACTURERS)

A new clause detailing the revised eligibility criteria for bidders is hereby added to the RFP. Bidders must be Lift Manufacturers and meet the following criteria, in adherence to prevailing government procurement norms:

- **A. Financial Standing:** Average Annual Financial Turnover in India for the immediate last three (3) consecutive financial years shall not be less than Rupees Two Hundred Crores (₹200 Crores).
- B. Infrastructure in India: The bidding firm shall possess the following in India:
 - 1. Manufacturing and testing facility.
 - 2. Research & Development (R&D) Centre.
 - 3. Dedicated training centre for its personnel.
- **C.** Manufacturing Experience: The manufacturer must have a minimum of fifteen (15) years of experience in manufacturing lifts.
- **D.** Production Capacity: The domestic production capacity of the manufacturer's factory in India shall not be less than one thousand (1000) lifts per annum.
- *E. Service Network:* The manufacturer shall have established service centers in a minimum of twenty-five (25) towns/cities across India, including at least fifteen (15) State Capitals including NCR, Delhi.

- **F. Testing Facility:** A testing tower in India must be available with a travel height of not less than twelve (12) meters for lifts with speeds up to 1.5 meters/second.
- **G. Spares Availability:** The manufacturer shall furnish a formal undertaking confirming the availability of spare parts for the entire operational life of the lift (defined as 15 to 20 years).

H. Standards and Quality Compliance:

- 1) The Lifts, inclusive of all safety features and testing procedures, must conform to the latest relevant updated Indian Standards (IS).
- 2) Quality Management Systems shall conform to IS/ISO-9001:2015.
- 3) The fire rating of car doors and landing doors shall be as per the National Building Code of India, 2016.

I. Service Performance:

- 1) The average downtime of installed lifts currently under the manufacturer's maintenance should not have exceeded eight (8) hours for minor faults and seven (7) days for major faults over the last one (1) year. Data for the last financial year must be provided.
- 2) The applicant must submit comprehensive details of their Service Level Agreement (SLA), including a toll-free number and a dedicated email address for lodging complaints and service requests.
- J. Mandatory Documentation: Bidders are required to submit verifiable documentary evidence to substantiate compliance with all the eligibility criteria. This includes, but is not limited to audited financial statements, certificates of incorporation, manufacturing licenses, detailed information on facilities (manufacturing, R&D, training), a comprehensive list of service network locations, technical specifications of the testing tower, the undertaking for spares availability, valid ISO certifications, and SLA documentation.

3. AMENDMENT TO SECTION 8: DEADLINE FOR SUBMISSION OF PROPOSALS

The deadline for the submission of proposals, as stipulated in Section 8 of the original RFP document, is hereby extended. The revised schedule is as follows:

New Deadline for Submission of Proposals: May 22, 2025, by 3:00 PM IST

Proposals received after this revised date and time will not be considered for evaluation.

4. REAFFIRMATION OF OTHER TERMS AND CONDITIONS

All other terms, conditions, technical specifications, and requirements stipulated in the original RFP document dated March 24, 2025, except as expressly amended by this Corrigendum, shall remain unchanged and in full force and effect. This Corrigendum No. 1 shall be construed as an integral part of the RFP document.

Bidders are required to sign and return a copy of this Corrigendum with their proposal submission as an acknowledgment of its receipt and acceptance of the amendments herein.











Revised Eligibility Criteria for Lift Works

 Average Annual Financial Turnover in India for immediate last three consecutive financial years shall not be less than ₹ 200 Crores.

- 2. The firm shall have in India:
- i. manufacturing and testing facility,
- ii. Research & Development Centre and
 - iii. dedicated training centre to train its personnel
 - Manufacturing experience of the manufacturer shall not be less than 15 years.
 - Domestic Production Capacity of the factory in India shall not be less than 1000 Lifts per annum.
 - The manufacturer shall have service centers in 25 nos. towns/cities including at least 15 nos. State Capitals in India.
 - 6. Testing Tower in India shall be available with travel height not less than:
 - i. 12 meters for requirement of lift speed up to 1.5 meter/second and
 - ii. 20 meters for requirement of lift speed above 1.5 meter/second with facility of testing at least 2 lifts simultaneously.
 - 7. The manufacturer shall furnish an undertaking regarding availability of spares for the entire life of the lift i.e. 15 to 20 years.
 - The Lifts including safety features and testing shall conform to relevant updated Indian Standards.
 - Quality Standards shall conform to IS/ISO-9001:2015.
 - 10. The fire rating of car door and landing door shall be as per National Building Code -2016.
 - 11. i) The Down Time of installed lifts, which are being maintained by the manufacturer, shall not be more than 8 hours (average) in case of minor faults and 7 days (average) in case of major faults in last one year. The data to be considered shall be for last financial year.
 - ii) Applicant shall have to submit details of Service Level Agreement (SLA) consisting of Toll free number, E-mail id for lodging complaints etc.
